Sub : E-Freight Initiative at CSI Airport, Air Cargo Complexreg

Reference to our earlier circular no:- 06/2013 regarding issuance of On-line DO Message. Attention is invited to all Airlines and Consolidators / Break Bulk Agents operating at Air Cargo Complex, CSI Airport, as E-Freight initiative and Regulatory requirement for the transparency of on-line transactions MIAL is in the process of implementing the issuance of Delivery Order Message mandatory through web portal www.gmax.gvk.com with effect from 9th June 2014.

1. All Airlines to issue on-line DO Message for the Master Airway bill and Consolidators / Break Bulk Agents to issue on-line DO Message for House Airway bill.
2. System has been configured to validate both the MAWB - DO and HAWB - DO message on-line before the generation of final Gate Pass.
3. All concerned are requested to kindly note that without the receipt of DO Message, system will not generate Gate Pass. Hence ensure that all concerned are registered for using the MIAL system. Also to state that without the issuance of MAWB - DO Message, HAWB -DO message cannot be issued as both the message are inter-linked.
4. 100% Generation of forwarding slip (Bank Challan) through MIAL On-line either bank / PD mode. Help desk counter for amendments and one time customer will be facilitated through MIAL counter. Also to note that KIOSK center is operative for trade facilitation at air cargo complex.


