

Sub : To streamline Export Operations at ACC....reg

Reference to the Customs Trade Facilitation Meeting discussions held on 2nd May 2014 and subsequent Joint Meeting held with all trade members on 6th May 2014 to appraise the current scenario of export operations and way forward joint action plan.

To streamline the export operations and for immediate solution to effect smooth export operations at CSIA, the following initiatives has been mutually agreed and decided for immediate implementation.

1. Vehicle with valid TSP for shipment loaded will be allowed to join the queue from dedicated lane marking area after obtaining token. Export Goods to be brought in ready for carriage condition.
2. Single Shipment having more than 800 pkgs and loaded in multiple vehicles to be pre-intimated to the MIAL Security / Export team for effective offloading / carting. All such vehicle to be queued together to avoid delay.
3. Freight Forwarders / CHA to submit the complete set of duly signed LEO documents within **One Hour** to the respective airlines carting agent and to avoid submission of documents in bunches.
4. Availability of respective carting agents in the shed to be 24 x 7 for acceptance of document with acknowledgement of date and time. All carting agents to be positioned at one common area. To make a record of late submission and also for non submission. The same detailed record to be sent to MIAL Export In-Charge the next day morning for onward submission to Customs.
5. All Airlines / their respective carting agents to ensure 100% carting of LEO done / documents accepted export cargo. Any pendency will lead to stoppage of fresh acceptance of that particular airlines.
6. Airlines / respective carting agent to ensure availability of X-ray screeners 24 x 7. If this is not implemented with immediate effect then MIAL will take over this activity through their Regulated Agent for all the airlines and bill accordingly.
