

CIRCULAR -08/2014

Sub : Effective Export and Import Operations at ACC....reg

In continuation of our earlier circular no:- 07/2014 dated 15th May 2014 and to ensure proper vehicular movement to facilitate trade and to have effective Export and Import functions at Air Cargo Complex, CSIA the following measures will be implemented with effect from 27th May 2014.

EXPORTS:-

1. Vehicle carrying export goods to be "ready for carriage" condition with valid TC (Terminal Charges Receipt). TC will be validated by MIAL Security team at the vehicle segregation point near EICI warehouse and only then the vehicle will be allowed to join the dedicated lane queue.
2. Vehicle without valid TC (Terminal Charges) Receipt will not be allowed to join the queue. The same will be re-routed to the parking area.

IMPORTS:-

1. Import Gate Pass generated to be handed over to the respective shed supervisor within 02 hours of generation for bringing the cargo to the dock and simultaneously Vehicle for the same to report to the truck dock within 01 hrs from the handover of GP to the supervisor. Total 03 hours buffer time is available for effective planning and smooth delivery.
2. Any queries / problem faced by the trade for import GP generation / acceptance and Vehicle management can contact the below mentioned officials for necessary actions.
